308/20	WELCOME / INTRODUCTORY REMARKS	
	Emma Woollett welcomed everyone to the first annual general meeting as Swansea Bay University Health Board, stating that it had been a very

	unusual year given the ongoing Covid-19 pandemic. She said it had been her honour to be appointed as chair but there was also sadness at the news that Tracy Myhill would be retiring. Work was now underway to recruit a worthy successor.	
309/20	SUMMARY OF THE YEAR	
	A presentation providing a summary of 2019-20 was received.	
	In introducing the presentation, the following points were raised:	
	 Tracy Myhill offered her thanks to the executive team for the progress made during the year; 	
	 It had been a challenging time due to the pandemic but the commitment and response from staff had been incredible, often at personal sacrifice; 	
	 It was an opportunity to learn from the changes made and to embed them; 	
	 A number of actions had been taken to respond to the pandemic, including establishing two field hospitals and creating a paediatric emergency and admission unit at Morriston Hospital; 	
	The support from the local community had been overwhelming in terms of donations for staff and patients;	
	- Tribute was paid to Liz Spooner, Jenelyn Carter, Linnette Cruz and Sharon Bamford, colleagues lost to Covid-19, as well as Gerallt Davies, paramedic with the Welsh Ambulance NHS Trust (WAST), who worked closely with the emergency department;	
	 There had been a number of changes within the executive team during the year and thanks was given to those currently in interim positions for stepping up; 	
	- A focus on supporting staff continued, including the launch of the #livingourvalues campaign and the implementation of the Guardian Service, enabling staff to confidentially raise concerns;	
	 The health board was working hard to be inclusive and had staff networks for those who were LGBT+ (lesbian, gay, bisexual, transgender/transsexual plus) and BAME (black, Asian, minority ethnic); 	
	- A number of digital developments had been made with the digitalisation of medical records as an example;	



- An enhanced seven-day occupational health service had been established to support staff during the pandemic and the team had been recent winners at the Personnel Today 'Occupational Health and Wellbeing Awards' along with the wellbeing team;
- Pressure ulcers had been reduced by 7% over the year 2019-20;
- A new support group for men in Swansea Bay concerned with their mental health, known as 'The Rally' had started;
- 'Hospital 2 Home' was supporting people over the age of 65 to return home as soon as they were well enough;
- While the need to respond to Covid-19 affected the way in which services could be provided, a large number of patients were seen, and where necessary, treated;
- Infection prevention and control ambitions were exceeded in all five core measures:
- 85% of patients referred urgently to cancer services were seen within the 62-day target and for three months, the health board was the best performing in Wales;
- By the end of the year, all stroke patients were admitted into a stroke bed within four hours and 100% of those needing a CT (computerised tomography) scan were seen within an hour;
- An improvement had been evident in unscheduled care performance thanks to a number of innovations and the health board was one of the best performing in terms of urgent ambulance response times;
- The work to increase access to planned care had started to take affect however routine services were paused in March 2020 due to the pandemic;
- An end-of-year financial position was reported as a deficit of £16.284 and while this was within the forecast, it meant that the budget was overspent which was a failure of a financial duty;
- The health board did meet its capital resource limit for the year;
- There was a long road to recovery ahead and while it was unclear as to how the pandemic would continue to develop, there were some initiatives planned including the modernisation of adult mental health services and moving some orthopaedic services to Neath Port Talbot Hospital to support the restart of some treatments.
