H&S	Radon Gas Monitoring in ABMU	
2018 028	The Group reviewed current arrangements in ABMU. Though some testing had been undertaken there was not a comprehensive system to comply with the requirements of the Ionising Radiation Regulations 2017 (IRR17). LH reported that tests had been undertaken in the potential high risk location of Murton clinic and the results were satisfactory. The paper recommended that financial support be sought to develop a comprehensive testing programme.
