Summary of Health and Safety key issues since last report to the Committee (Reporting period: 1st August 2021 to 31st August 2022)

This paper provides an update to the Health & Safety Committee on matters of health and safety overseen by the service group.

Primary, Community & Therapies Service Group (PCTSG) is a diverse group; the health and safety governance arrangements are currently being reviewed to ensure reporting requirements are aligned and to avoid duplication with quality & safety structures. The Terms of Reference for the PCTSG Operational Health & Safety Group is currently under review and work plans are being developed. The Health and Safety Operational Meeting reports to PCTSG Board on a quarterly basis. The Associate Director of Operations Chairs the Health & Safety meeting, and is the accountable officer for all areas of health & safety for the Service Group.

Staff incidents

Between August 2021 and August 2022, there were 111 incidents reported on Datix that affected staff. These are broken down as follows:



Four of the 111 incidents were reported as moderate severity, the remaining were low level incidents. Adherence to policy and training were included as lessons learned.

RIDDOR reportable incidents

Between August 2021 and August 2022, there were 7 RIDDOR reportable incidents as follows:



One of these incidents occurred on hospital premises, and 6 happened either at patient's home or on route to patient's home.

All but one were low level incidents. Themes from lessons learned included reiteration of environmental risk assessments.

Performance Progress to include: Statutory and Mandatory Training; PADR compliance; Serious Incidents; Staffing and Sickness Levels;

Statutory and Mandatory Training:

• Statutory and mandatory compliance for the group was above target at 89.33% in July 2022, previously 88.77% in June 2022.

PADR Compliance:

• PADR compliance rate of 77.47% in July 2022, previously 76.57% in June 2022. Heads of Service to have PADR's updated by 20th November 2022.

Serious Incidents:

There were no serious incidents relating to Health and Safety within the reporting period

Staffing and Sickness Levels:

- Infectious diseases was the highest reason for sickness absence, followed by Chest & respiratory. Anxiety/stress/depression/other psychiatric illnesses is also still a concern as the third highest reason for absence.
- Sickness in month for June 2022 was 7.34%, a decrease from the final May 2022 position of 7.42%.

- Cumulative sickness in June 2022 was at 7.72%, which was an increase from the May 2022 position of 7.61%.
- Long-term sickness decreased in month from 5.43% in May 2022 to 4.63% in June 2022.
- Short-term sickness increased from 1.99% in May 2022 to 2.71% in June 2022.

COVID-19 Health and Safety Issues (PPE, social distancing, visiting)

- Staff have been notified of the opportunity to book their Covid-19 and Flu vaccinations and provided with a link.
- Staff have been notified of the changes to IPC guidance in relation to PPE, social distancing and visiting.
- The numbers of COVID related absences reported have decreased during August, with a decline from 23 Symptomatic on 1 August 2022 to 15 Symptomatic on 19 August 2022.
- Many services have reported staffing issues

Current issues for 2022-2023 for the Attention of the Committee

Storage of medical and therapeutic notes to comply with Blood Inquiry continues to be a Health & Safety risk for the service group. This requires further discussion to understand what information is required to be retained, particularly in view of some of the therapies.

Levels of staff sickness, particularly in relation to anxiety, stress, depression continue to be an area for concern

PADR performance may reflect issues with reporting onto ESR resulting in under reporting.
