#### 1. Situation

This report provides the Committee with a summary in respect of activity relating to external inspections and letters from inspectorates for late November and December 2017.

## 2. External Inspections Late November – December 2017

There have been three inspections in the Health Board since the last report was submitted to the Committee, summarised as follows:

## PICU & Ward 14 Princess of Wales Hospital (Mental Health Act Monitoring Visit)

22nd November, HIW paid an unannounced visit to Ward 14 and PICU Princess of Wales Hospital. The Locality Manager received verbal feed back on the day. The feed back was complimentary however there were some minor issues raised regarding repair to furnishings and privacy during visiting times. The unit is addressing these issues and an action plan has been submitted.

### Gwelfor Ward Cefn Coed Hospital

5th December, The Community Health Council Visited Gwelfor Ward. The feedback received was excellent. None of the patients seen could think of any areas for improvement. The final report will be sent to the hospital manager at Cefn Coed Hospital once received.

## Ward 14 Princess of Wales Hospital

9th January, The Community Health council paid an annanounced visit. The verbal feedback was good, they had no concerns in any areas, patient feedback was good and they made positive comments on the welcome they were given, the calm and organised feel of the ward and the friendliness of the staff. A written report will follow.

## 4. Reviews Sent to Welsh Government

During the period no results of reviews were sent to Welsh Government.

#### 5. Shared Learning

Neath Port Talbot Hospital reported the following learning outcomes as a result from the correspondence and visits form HIW and CHC inspections.

- Joint work with the CHC has commenced a joint patient survey project, visiting
  patients post-discharge to ask about their experience throughout their treatment
  journey. This project a partnership project between PEAS and CHC and has been
  running since November 2017. The project has been extended and will report to
  the CHC and Unit in April.
- An example of a service change undertaken as a result of a CHC visit is the installation of a display screen in MIU informing patients of how long the average wait is. Staff in the Unit are receiving training on placing information on the screen. It is anticipated that it will be fully functional by February.
- Neath Port Talbot Management and Delivery Board received a paper last year on learning from the HIW reviews of WAST and Aneurin Bevan Health Board. As a result of this the QSI Manager went on a best practice visit to WAST to learn about how they manage concerns and Serious Incidents.

Future External Inspection papers will report on learning outcomes within the other Service Delivery Units.
