I refer to your Freedom of Information Act Request acknowledged by ourselves on 30th April 2019. Your request sought information relating to deaths.

Please note that from 1st April 2019 responsibility for providing healthcare services for people in the Bridgend County Borough Council area transferred from Abertawe Bro Morgannwg University Health Board to Cwm Taf Morgannwg University Health Board. In light of this change to ABMU's responsibilities, the organisation's name has changed to Swansea Bay University Health Board.

However as your request asks for data relating to 2017 and 2018 we have included within our response Bridgend data.

For each of the years 2017 and 2018 please may you provide me with:

1. The total number of adult (aged 17 and above) deaths within your Health Board (on Health Board sites) between 1st January and 31st December of each year.

2017 - 3348

2018 - 3139

2. The number of Hospital (consent) autopsies carried out on adult (aged 17 and above) deaths which occurred between 1st January and 31st December of each year.

2017 - 5

2018 - <5*

*The Health Board holds information of the nature you are seeking however the number of incidences is very few. This being the case it is considered that such information should be withheld under Section 41 of the Act.

Section 41 of the Act sets out an exemption from the right to know where the information requested was provided to the public authority in confidence. The component which is applicable relates to the disclosure of the information would give rise to an actionable breach of confidence. In other words, if the Health Board disclosed the information being sought this could lead to their identification which would be unfair and inappropriate. A duty of confidentiality does continue after the death of an individual to whom that duty is owed. Where there is a legally enforceable duty of confidentiality owed to a living individual, after death it can be enforced by the deceased's personal representative.

Under the terms of the Health Board's Freedom of Information policy, individuals seeking access to recorded information held by the Health Board are entitled to request internal review of the handling of their requests.
