I refer to your Freedom of Information Act Request acknowledged by ourselves on 6th August 2019. I apologise for the delay in responding. Your request sought information relating to Primary Sjogren Syndrome.

How many patients with Primary Sjogren's Syndrome are being treated in Rheumatology outpatients departments within SBUHB (Moriston Hospital Rheumatology Dept., Singleton Hospital Rheumatology Dept. and Neath and Port Talbot Hospital Rheumatology Dept.) for the latest year you have these statistics.

Please note that out-patient consultations are not clinically coded and therefore the Health Board does not routinely record this information. However within Rheumatology the Health Board uses a stand-alone system called Cellma. This system is dependant on clinicians completing the diagnosis section, which is not mandatory. Therefore where this section has been completed, the number of patients recorded on this system with Primary Sjogren's Syndrome is 254 for the period - July 2018 to July 2019.

However as mentioned above please note this will not be an accurate figure. To obtain the total numbers of patients with Primary Sjogrens Syndrome would involve a manual trawl and search of patient records which we have estimated would significantly exceed the 18 hours limit set down by the FOI Act as the reasonable limit. Section 12 of the FOI Act provides that we are not obliged to spend in excess of 18 hours in any sixty day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
