I refer to your Freedom of Information Act Request acknowledged by ourselves on 7th August 2019. Your request sought information relating to shoulder operations.

Please note from 1st April 2019 responsibility for providing healthcare services for people in the Bridgend County Borough Council area transferred from Abertawe Bro Morgannwg University Health Board to Cwm Taf Morgannwg University Health Board. In light of this change to ABMU's responsibilities, the organisation's name has changed to Swansea Bay University Health Board. Therefore this response takes into account these changes. Information prior to 1st April 2019 will be ABMU Health Board data and will include Bridgend information.

1. How many emergency shoulder operations have taken place this year?

From 1st January 2019 to 30th June 2019, there have been fewer than 5 emergency operations. We are unable to provide you with the exact number of patients as due to the low numbers, there is a potential risk of identifying individuals if this was disclosed. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This information is protected by the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. This exemption is absolute and therefore there is no requirement to apply the public interest test.

2. How many shoulder operations have taken place this year?

From 1st January 2019 to 30th June 2019, there have been 109 elective operations.
