PAP applies to NHS England only. Therefore the Health Board would not hold this information.
- 2. Between 2016 – 2019, how many cases have been referred to the performers list decision panel (PLDP) and of these cases, what were the outcomes i.e. removal, conditions, no action. If the data could be provided both by way of overall statistics and then breakdown for individual practitioner groups;**
PLDP applies to NHS England only. Therefore the Health Board would not hold this information.
- 3. Between 2016 - 2019, how many interim suspensions have been initiated and imposed by the board.**
