I refer to your Freedom of Information Act Request acknowledged by ourselves on 15<sup>th</sup> July 2019. Your request sought information relating to gambling in under 18s.

**How many people under the age of 18 were referred for help with a gambling addiction in your jurisdiction between June 2014 and June 2019?**

I can confirm that Cwm Taf Morgannwg University Health Board hosts the Child and Adolescent Mental Health Service (CAMHS). This service provides specialist mental health services to children and young people. CAMHS provides community mental health services for 1.2million people, covering the areas of Merthyr, Rhondda Cynon Taf, Cardiff and Vale, Bridgend, Neath Port Talbot and Swansea.
