I refer to your Freedom of Information Act Request acknowledged by ourselves on 20th November 2019. Your request sought information relating to negligence.

1. Could you tell me how much money has Swansea Bay University Health Board (including as ABMU) paid out the last ten years in compensation following upheld complaints from patients and their families over clinical negligence and breaches of duty of care?

We have recently responded to an FOIA request regarding this subject. Therefore I can confirm that the information you are seeking is held on our website within our FOIA disclosure log. Under Section 21 of the Freedom of Information Act (information accessible by other means), we are not required to provide information in response to a request if the information is already reasonably accessible to you. May I therefore recommend that you look at this link to our website:

2. Could you also list the reasons and their corresponding settlement?

Due to the number of claims each year, to obtain this information would involve a manual trawl and search of records which we have estimated would significantly exceed the 18 hours limit set down by the FOI Act as the reasonable limit. Section 12 of the FOI Act provides that we are not obliged to spend in excess of 18 hours in any sixty day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
