Could you please provide me with the overhead costs (excluding staff costs) of your health board and also this figure provided as a percentage please?

You clarified on 4th December 2019 that you required the information for financial year 2018/19, and the definition of overheads was per National Costing Standards guidance. You also clarified that you wanted a percentage of overhead costs against total costs.

I can confirm that the information you are seeking is held within our annual accounts on our website.
