I refer to your Freedom of Information Act Request acknowledged by ourselves on 9th January 2020. Your request sought information relating to inter-uterine devices. You clarified on 9th January 2020 that you require information for GP practices in the Health Board.

1. List of all practices (including address and postcode details) that are contracted to fit/offer an Internal Uterine System/Device (coil) fitting service.

2. How many IUS/Ds (coils) have each practice fitted/removed/reviewed/claimed for in the financial year 2018/19?

We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. Articles 5, 6, and 9 of GDPR. This exemption is absolute and therefore there is no requirement to apply the public interest test.

3. How much are contracted practices paid per IUS/IUD (coil) procedure (fit, remove, review or other) they currently contracted to pay per fit?

This figure is withheld. Section 43 of the Act sets out an exemption for the right to know if release of the information is likely to prejudice the commercial interests of any person (a person may be an individual, a company, the public authority itself or any other legal entity). Section 43 is a qualified exemption. That is, it is subject to the public interest test.

The Health Board accepts that there is a public interest in ensuring openness and transparency and there is an interest in the public being aware of how much money is spent and the benefits derived from that expenditure. However within this particular market prices are locally agreed with the practices and the Health Board. Therefore the Health Board believes that disclosure of information in a manner which fails to protect the interests and relationships arising in a commercial context could have the effect of discouraging practices from agreeing with the Health Board because of fears that the disclosure of information could damage them commercially. In turn this could then jeopardise the Health Boards ability to compete fairly and pursue its function to bring forward development in the area and obtain value for money. It was therefore decided that it is not in the public's interest to disclose this information.

4. If fitting service is available, how many insertions and removals have been undertaken in the last 12 months for each practice?

Please note that the only mechanism we have for collecting IUD removal data is via the annual audit figures which are submitted by each practice. The deadline for 2019 data is August 2020 therefore some figures are still missing. The only information we hold for 2019 is 01st January – 30th November 2019, therefore this is the data we have provided.

7. If a practice does not have its own fitting service, which practice/clinic/hospital do they refer the majority of their patients that require an IUS/D (coil) fit to (type, name, address and postcode) and how many do they refer?

Swansea Bay Health Board does not hold this information centrally, it is dependent on each practice. However, we have provided a list of the Sexual Health Clinics to which GP practices would refer patients if they do not provide their own fitting service.
