I refer to your Freedom of Information Act Request acknowledged by ourselves on 21<sup>st</sup> January 2020. Your request sought information relating to facilities at prisons.

**1. Confirm whether any prisons within your jurisdiction incorporate a 24 hour inpatient facility / hospital wing;**

No, Swansea Prison does not have an inpatient facility.

**2. Provide all policies in place from 1 January 2016 onwards governing the transfer of a prisoner to any such prison from a prison that does not have such a facility;**

Not applicable – no such policies exist.

The nearest prison with an inpatient facility would be Cardiff. This would be arranged between the two prisons and health boards.

**3. Provide all policies in place from 1 January 2016 onwards specifying the resources which should be made available in a 24 hour inpatient facility / hospital wing within any such prison, including but not limited to the treatment of prisoners suffering from type 1 diabetes;**
