I refer to your Freedom of Information Act Request acknowledged by ourselves on 28<sup>th</sup> January 2020. Your request sought information relating to smoking cessation.

## 1. Can you please detail the smoking cessation service provision offered by your Health Board which is targeted specifically at women using your maternity services?

All women that book for pregnancy with their named midwife are asked about their smoking status and this is recorded within the handheld maternity records. Women that report as smoking at this stage are automatically referred to the 'Help Me Quit' Wales team.

The Help Me Quit team have trained smoking cessation advisors that identify the best source of support and nicotine replacement therapy for individual women. The team make contact by telephone to commence the support, although women may also engage with local pharmacies that can offer face to face, ongoing support.

Carbon Monoxide (CO) testing is part of routine antenatal care, and follow up referrals are sent for women that provide high CO readings at subsequent appointments.

Quit attempts are currently supported by the named midwife as supplement to the support given by Help Me Quit. Midwives also enquire about partner and family smoking if passive smoking is a risk factor and can also refer partners and family members to the Help Me Quit services.
