I refer to your Freedom of Information Act Request acknowledged by ourselves on 4th March 2020. We apologise for the delay in responding. Your request sought information relating to specialist mental health and learning disabilities.

I am writing to request information on spend associated with specialist mental health and learning disability inpatient care for children and young people, aged under 25, for whom your organisation is responsible for securing healthcare. (This would generally include all children and young people aged under 25 who are considered 'usually resident' in your organisation's area.)

This would include care provided in secure/forensic settings, and in non-secure settings. This would include recovery, rehabilitation and residential services that would commonly be referred to as 'specialist inpatient', or 'Tier 4' in the context of CAMHS. This would include 'locked' units.

This would not include community or other daycase services. This would not include, for example, commissioning a third sector organisation to provide a community counselling service. This would not generally include a residential placement in a specialist college for people with learning disabilities. This would not include care that your own organisation has provided, even if you have internal budgets and billing processes.

You are welcome to provide further details about how you have interpreted the request.

The Health Board does not hold information for the patient group under 18's. I can confirm that Cwm Taf Morgannwg University Health Board hosts the Child and Adolescent Mental Health Service (CAMHS). This service provides specialist mental health services to children and young people. CAMHS provides community mental health services for 1.2million people, covering the areas of Merthyr, Rhondda Cynon Taf, Cardiff and Vale, Bridgend, Neath Port Talbot and Swansea. Please note we do not hold the information prior to 2013/14.

We are unable to break this information down by year and company for patient numbers, due to the very small numbers involved as there is a potential risk of identifying individuals if this was disclosed. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This information is protected by the General Data Protection Regulation (GDPR) and Data Protection Act



2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. This exemption is absolute and therefore there is no requirement to apply the public interest test.

However we can tell you that for the total period requested there were 7 males and 7 females.
