I refer to your Freedom of Information Act Request acknowledged by ourselves on 12th May 2020. Your request sought information relating to care home discharges.

Please can you provide the numbers of people who have been transferred to care homes across hospitals from ABM University Health Board/SBU Health Board for each individual month from January 2019 to April 2020? (Providing data from before the crisis began will allow a fair comparison with how many people typically undergo such transfers.)

Please note that some patients may be admitted to hospital more than once, therefore they will be counted separately for each occasion they are discharged. The figures also include patients admitted initially from a care home and returned there on discharge.
