I refer to your Freedom of Information Act Request acknowledged by ourselves on 26th April 2021. Your request sought information relating to Pen-Y-Bont Health Ltd, The Medical Centre, Pencoed.

1. Please could the SBUHB tell me what monies have been paid directly from it, to the above company, and for what purposes/s during the 12 months prior to Cwm Taf Morgannwg University Health Board being established on 1 April 2019?

The total sum of monies paid directly to Pen-Y-Bont Medical Centre by the former ABMUHB in the 12 months prior to 1 April 2019 is £85,115.56. The purpose of the payments include: The provision of a Mental Health Counselling Service on behalf of the East Cluster; Out of Hours Call Handling Sessions; GP cover to facilitate protected time for learning and website costs on behalf of the Cluster; and reimbursement of travel costs (an ABMU bursary for awards ceremony attendance).

2. Also, what record exists of the contact point for this company?
