I refer to your query dated 1<sup>st</sup> October 2021 relating to our response to your Freedom of Information Act Request sent to you on the same date.

You asked us to revisit one question from your original request as below;

**On what date did regular testing of all asymptomatic hospital staff begin?**

While there was an intention for Lateral Flow testing to have broad application, there never was a requirement for *all* staff to participate. It has always been on a voluntary basis.

The test kits arrived at Swansea Bay University Health Board on 16th December 2020 and testing started in selected areas from 20th December 2020, with a wider roll-out from 11th January 2021.
