I refer to your Freedom of Information Act Request acknowledged by ourselves on 2<sup>nd</sup> February 2021. Your request sought information relating to deaths from COVID-19.

**How many people died in Singleton Hospital and Morrison Hospital from Covid-19 alone?**

**As in they died only due to Covid-19. I can only see the figures that you publish online, but these are deaths within 28 days of a positive Covid-19 test, so they could of died from other causes, I just want to know the exact figures from the 1 January 2020 until the 20 December 2020 of people that have died due to Covid-19 and not anything else, please?**

I can confirm that the information you are seeking is held on our Disclosure Log on our website.
