I refer to your Freedom of Information Act Request acknowledged by ourselves on 1st March 2021. Your request sought information relating to deaths from COVID-19.

I note that your original request asks for information for Abertawe Bro Morgannwg Health Board. From 1st April 2019 responsibility for providing healthcare services for people in the Bridgend County Borough Council area transferred from Abertawe Bro Morgannwg University Health Board to Cwm Taf Morgannwg University Health Board. In light of this change to ABMU's responsibilities, the organisation's name has changed to Swansea Bay University Health Board.

I am writing to you to request the number of people that have died in Swansea Bay Health Board hospitals, in 1 year ending 27-02-2021 from Covid 19 virus alone.

To clarify, I see the figures published online, but I see they cover mortality within 28 days of a positive Covid 19 test, but death could have been through other causes.

I would like to see the figures for deaths recorded where Covid 19 is the only cause of death, without any other reason given on the death certificate.

I can confirm that the information you are seeking is held on our Disclosure Log on our website. Under Section 21 of the Freedom of Information Act (information accessible by other means), we are not required to provide information in response to a request if the information is already reasonably accessible to you. May I therefore recommend that you look at this link to our disclosure log, which contains details of where you can obtain the information you require:
