I refer to your Freedom of Information Act Request acknowledged by ourselves on 17th June 2021. Your request sought information relating to expenditure.

What I am looking for is data about payments made by NHS Wales to external suppliers for purchases of goods and services. What is requested is a list of all such payments to external suppliers, ideally in Microsoft excel or CSV format, with as much of the following information as possible for each payment.

- **Name of the supplier**
- **Amount paid**
- **A date for the transaction**
- **Some cost account or cost centre so I can know roughly what a specific purchase was for.**
- **A unique invoice-id or a transaction-id number for each payment.**

The request applies to payments made between 2019-01-01 and 2020-12-31.

Please note that we do not hold the figures for NHS Wales, we are only able to supply information relating to Swansea Bay Health Board.

Please find attached a breakdown of payments paid to organisations external to NHS Wales. Any numbers that indicate a minus (negative) figure reflect a refund/credit note.
