I refer to your Freedom of Information Act Request acknowledged by ourselves on 25<sup>th</sup> June 2021. Your request sought information relating to deaths within SBUHB.

Please note that Swansea Bay University Health Board would only hold information for deaths within our hospital sites. Any deaths in the community would be held by the Registrar of Deaths.

**How many people died from Flu in the Neath Port Talbot County Council region in the year 2019, 2020 and up until 1 January - 24 June 2021 please?**

The Health Board's information systems do not code the cause of death; such information could only be obtained by reference to the individual's death certificate. Death certificates are not held by the Health Board, but by the Registrar of Deaths (in the local authority), please contact them for this information.

The Office for National Statistics (ONS) regularly publishes influenza and pneumonia death data on their website. You can find this on <https://www.ons.gov.uk/peoplepopulationandcommunity/birthsdeathsandmarriages/deaths/datasets/weeklyprovisionalfiguresondeathsregisteredinenglandandwales>

**Also, I want to know how many people have died since 1 January 2020 from Covid 19, and only Covid 19, not within 28 days of a positive test of Covid 19 as most published figures show. I just want to know the figures of those who have died of Covid 19 and Covid 19 alone since 1 January 2020.**

I can confirm that the information you are seeking is held on our Disclosure Log on our website. Under Section 21 of the Freedom of Information Act (information accessible by other means), we are not required to provide information in response to a request if the information is already reasonably accessible to you. May I therefore recommend that you
