I refer to your Freedom of Information Act Request acknowledged by ourselves on 2nd March 2021. Your request sought information relating to deaths from COVID-19.

Please provide me with ALL COVID 19 deaths with comorbidities from March 20th 2020 to present day 24/02/2021.

In the period 20th March 2020 to 24th February 2021, there were 638 deaths in our hospitals where COVID-19 was listed on the death certificate either as the cause of death or as a contributing factor. If you require a further breakdown of these figures, please contact the ONS as per the below question.

Please provide me with information on ALL COVID 19 deaths without comorbidities from March 20th 2020 to present day 24/02/21.

I can confirm that Swansea Bay University Health Board does not hold this information. The Office for National Statistics (ONS) provide us with data relating to COVID deaths where COVID-19 is mentioned anywhere on the death certificate, including as a contributing factor. We are not able to split this data further in order to exclude contributing factors to death, therefore we recommend that you contact the ONS, who may be able to provide this breakdown for you on foi.team@ons.gov.uk
