In the attachments, where fewer than 5 has been indicated (<5) we are unable to provide you with the exact number of patients/incidents as due to the low numbers, there is a potential risk of identifying individuals if this was disclosed. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This information is protected by the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. This exemption is absolute and therefore there is no requirement to apply the public interest test.

Please note that for categories where we have redacted a low number as detailed above we have also removed any totals, as if combined with other data provided in the sheets, this could enable the reader to calculate the withheld data.
