**Under the Freedom of Information Act 2000, I would like to request the following information if possible:**

- **Infection prevention and control audit reports for December 2020 for the Neuro-Rehab Unit (NRU) in Neath Port Talbot Hospital (I believe the report dates are 11/12/20 and 17/12/20)**

Please find attached. The names of staff have been redacted from these reports. This data is classed as personal data as defined under the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This exemption is absolute and therefore there is no requirement to apply the public interest test.

- **If possible, minutes of an 'Outbreak meeting' held on NRU dated 14/12/20**

Please find attached. Where information has been redacted from the minutes, this is where there is a potential risk of identifying individuals if this was disclosed. This will include instances where the number of patients are less than 5 and therefore if the exact numbers were released there is a potential risk of identification. Therefore, the data redacted is classed as personal data as defined under the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000.
