For information in relation to suicide prevention in mental health wards. You asked us to note that you are defining suicide as a death recorded on incident reporting system and submitted to the National Learning and Reporting system as suicide.

1	What was the total combined confirmed number of annual deaths by suicide that occurred while the patient was under the care of mental health services (any age) and learning disabilities' inpatient services?	<p>The Health Board holds information of the nature you are seeking however the number of incidences over this time period is very few. This being the case it is considered that such information should be withheld Section 41 of the Act and therefore denied your request.</p> <p>Section 41 of the Act sets out an exemption from the right to know where the information requested was provided to the public authority in confidence. The component which is applicable relates to the disclosure of the information would give rise to an actionable breach of confidence. In other words, if the Health Board disclosed the information being sought this could lead to their identification which would be unfair and inappropriate.</p> <p>A duty of confidentiality does continue after the death of an individual to whom that duty is owed. Where there is a legally enforceable duty of confidentiality</p>		



		owed to a living individual, after death it can be enforced by the deceased's personal representative.
