Please note that from 1st April 2019 responsibility for providing healthcare services for people in the Bridgend County Borough Council area transferred from Abertawe Bro Morgannwg University Health Board to Cwm Taf Morgannwg University Health Board. In light of this change to ABMU's responsibilities, the organisation's name has changed to Swansea Bay University Health Board.

However as this response asks for data prior to 1st April 2019, we have provided the information that ABMU Health Board held which will include Bridgend data.

Swansea Bay Health Board recognise how distressing it is for people who have had long waits for surgery, and understand the devastating effect it can have on their lives. The pandemic has stretched NHS resources to the limit, leading to record waiting times for orthopaedic and other surgery across the UK. This is on top of the usual winter and emergency pressures, which have only worsened an already challenging situation.

Last year, the health board agreed to create a series of centres of excellence at its main hospital sites, allowing it to work through the backlog as quickly and efficiently as possible. The plans include a centre of excellence for planned orthopaedic and spinal surgery at Neath Port Talbot Hospital. It will mean additional beds and operating theatres for orthopaedic surgery, increasing capacity by around 3,000 cases a year.

The centre of excellence at Neath Port Talbot Hospital is a key part of the health board's strategic Changing for the Future programme. Orthopaedic waiting lists, which were already very long before Covid-19, were worsened by the effects of the pandemic. Over half of our patients have now been waiting more than two years for orthopaedic surgery.

Neath Port Talbot Hospital plans to offer a ring-fenced elective service aimed at powering through the majority of patients on these lists.

Morriston Hospital will continue to be responsible for orthopaedic trauma patients and orthopaedic patients with more complex needs. The health board is actively looking at

how best to serve this last group.

We are in the construction stages and anticipate the new theatres will become operational by June 2023.

Please note that Neurosurgery is not performed within Swansea Bay Health Board hospitals. These patients are referred to Cardiff and Vale University Health Board. We therefore do not have a "Neurosurgery" category in our complaints, operations or incidents recording systems. We have, however, provided the number of data requested for the remaining categories.
