Please note that the numbers we have provided are the numbers of incidents recorded in the requested time periods, broken down by the initial "severity" entered into our incident reporting system Datix at the time the incident was logged. This initial "severity" level is subject to interpretation by the individual submitting the incident/inputting the data.

These severity levels are not necessarily reflective of the final outcome of each incident, as they have not yet been investigated and closed. Please be aware that these numbers are indicative only, and could change.

You asked:

- **How many DATIX reports were recorded in 2022 that expressed safety concerns regarding staffing levels?**
432 reports
- **How many DATIX reports were recorded in 2021 that expressed safety concerns regarding staffing levels?**
- **How many DATIX reports were recorded in 2020 that expressed safety concerns regarding staffing levels?**
- **How many DATIX reports were recorded in 2019 that expressed safety concerns regarding staffing levels?**
- **How many DATIX reports were recorded in 2018 that expressed safety concerns regarding staffing levels?**

We have recently responded to an FOIA request regarding this subject. Therefore I can confirm that the information you are seeking is held on our website within our FOIA disclosure log. Under Section 21 of the Freedom of Information Act (information accessible by other means), we are not required to provide information in response to a request if the information is already reasonably accessible to you.
